

## Harley-Davidson's 2018 ABCs of Touring HOG Contest

### Official Rules

**NO PURCHASE NECESSARY TO ENTER OR TO CLAIM A PRIZE. THIS IS A SKILL-BASED CONTEST; THIS IS NOT A GAME OF CHANCE. WINNERS WILL BE CHOSEN BASED ON THE STATED CRITERIA.**

**OPEN ONLY TO HARLEY OWNERS GROUP (HOG) MEMBERS OF THE 50 UNITED STATES (INCLUDING DISTRICT OF COLUMBIA) AND CANADA.**

**SPONSOR OBTAINS RIGHTS FROM ENTRANTS TO USE CONTENT SUBMITTED AS PART OF THE CONTEST.**

**INDIVIDUALS PARTICIPATE AT THEIR OWN RISK. DO NOT BREAK THE LAW OR ENDANGER YOURSELF OR OTHERS WHEN TAKING PHOTOS OR OTHERWISE PARTICIPATING IN THIS CONTEST.**

**SPONSOR:** Harley-Davidson Motor Company, Inc. ("Sponsor"), 3700 W. Juneau Ave., Milwaukee, WI 53208.

**ELIGIBILITY:** To participate in Harley-Davidson's 2018 ABCs of Touring HOG Contest (the "Contest"), you must be, as of the time of entry: (i) a legal U.S. or Canadian resident 18 years of age or older and have reached the age of majority in your respective state or province of residence, and (ii) a full or associate Harley Owners Group ("HOG") member. Employees of Sponsor and its participating dealers and retailers, affiliates, sales representatives, distributors and promotional and other vendor agencies, their respective parent companies, affiliates, subsidiaries, service agencies, independent contractors involved in the promotion, and the immediate family (parent, spouse, including common law spouse, sibling, child, grandparent, grandchild, regardless of where they reside) and household members of all such employees, are NOT eligible. Contest is subject to all federal, state, provincial/territorial and local laws and regulations. Void where prohibited or restricted by law.

**HOW TO ENTER:** The Contest runs from January 1, 2018 to December 31, 2018 (the “Contest Period”). Entries submitted after 11:59 p.m. Central Time (“CT”) on December 31, 2018 are not eligible.

If you are a U.S. or Canadian HOG member, you may enter by logging into your HOG account and going to [hog.com/abc](http://hog.com/abc) during the Contest Period. (If you do not have a HOG account, please go to [hog.com](http://hog.com) to set up a free account.) At the Contest website, you will find a menu of categories under which you may submit a photo to earn point/s. Select the appropriate category and submit your photo as instructed. Limit one (1) Contest entry per HOG member. *Please see below for additional instructions regarding photo submission requirements, categories, and allocation of points.*

The use of any automated devices is prohibited. Sponsor is not responsible for lost, late, stolen, illegible, corrupted, damaged, mutilated, garbled, incomplete, altered, or otherwise irregular or misdirected entries or entries not received for any other reason, and any such entries will be judged void and disqualified at Sponsor’s sole discretion. The information you provide will be used consistent with Sponsor’s Privacy Policy. Entries become property of Sponsor and will not be returned.

**PHOTO SUBMISSION – REQUIREMENTS:** The following requirements apply to photos submitted by HOG members for purposes of this Contest:

- All photos must be submitted online at [hog.com/abc](http://hog.com/abc).
- Photo formats accepted are: **.jpg, .gif, .png**. Each photo must not exceed 5MB in size. Images must be clear and names/signs must be legible in submitted prints. Photos that are blurred, fuzzy, illegible, or unrecognizable, based on the sole discretion of the Sponsor, will not receive points.
- The same photo may be used for multiple categories by uploading the same photo for each respective category. Please note, however, that you must upload a photo to each category in order to get the associated points for that category.

- All photos must be taken during the Contest Period. Photos taken outside the Contest Period are not eligible, and submission of such photos may result in disqualification at the sole discretion of the Sponsor.
- Your Harley-Davidson motorcycle must be in each photo. A Harley-Davidson® motorcycle rental through EagleRider is also acceptable.
- Either the cover of a 2018 HOG® magazine or the 2018 H.O.G. Touring Handbook must be clearly identifiable in each photo. Go to [hog.com/abc](http://hog.com/abc) to download a printable version of the HOG magazine cover.
- You, the entrant, must appear in at least five photos.
- An “official sign” must be in each photo. An official sign is defined as:
  - A government building with the name of the city, village, town, county, state, territory, or country on it. Examples of government buildings are post offices, city halls, or police stations. Examples of locations that **WOULD NOT** count as a government building are libraries, vehicles, schools, water towers, and museums.
  - An authorized Harley-Davidson dealership may be used to designate a city, state, or province. It may also be used to obtain up to 25 H-D® Dealership points. Photos of the dealership must include the dealership building with the name of the dealership on it. The first letter of the actual city where the dealership is physically located is the letter for which you will receive a point. For example, Harley-Davidson of Charlotte is physically located in Matthews, NC, so you would receive credit for the letter “M” for a photo of that dealership. For photos of dealerships, the name of the city and state of the dealership must be included in your description before submitting.
  - A sign posted by a government body that is physically located within the boundary of the place it identifies. Mileage markers and directional signs do not qualify.
  - For categories with an alphabetical component (*i.e.*, submitting official sign photos from A-Z), the letter used for the Contest will be the first letter of the location as it would appear in a phone book or government directory. By way of example, an official sign from “Oak Creek” could be used to get points for the cities, village, town, or municipality category as a city starting with the letter “O”, but this same photo could not be used to get points for “C” in this same category.

Photos must be entrant’s original creation and may not include copyrighted, trademarked, patented or previously published material. Entry requiring license or usage rights from any third party is not eligible. Entry may not display any trademarked or copyrighted brand names/logos,

except those of Sponsor's brands. If necessary, entrants should use their toolbar to blur out any brand names, logos, or trademarks. Entry cannot defame or invade the rights or privacy of any person, living or deceased, or otherwise infringe upon any third party's personal, proprietary, or intellectual rights. Entry cannot contain illegal or unlawful material, and must not promote bigotry, racism, harm, or discrimination. Entry must be consistent with Sponsor's reputation in the marketplace and must be suitable for audiences of all ages. Entries which, in Sponsor's sole discretion, contain any type of vulgarity or objectionable content will be disqualified. Entries that do not meet these stated criteria, or entries that (in Sponsor's sole discretion) may technically meet the stated criteria but do not reflect the intent and the spirit of the contest, are not eligible.

Entry constitutes entrant's certification that he/she: (i) is the owner of the entry, (ii) is able and authorized to submit it, and (iii) has received the consent of anyone pictured. By submitting entry, entrant agrees to indemnify and hold harmless Sponsor, participating dealers and retailers, affiliates, sales representatives, distributors and promotional and other vendor agencies, their respective parent companies, affiliates, subsidiaries, service agencies, independent contractors, and the officers, directors, employees, agents and representatives of any of the above organizations involved in this contest (the "Released Parties") from any and all claims, damages, expenses, costs (including reasonable attorney fees) and liabilities (including settlements), resulting from or relating to entrant's submission, or any information supplied or represented to Sponsor by entrant.

**SCORING SYSTEM:** Points will be allocated as follows, with maximum points for each category stated where applicable.

- One (1) point for each city, village, town, township, or municipality sign from A-Z. Only one point per letter. (26 points maximum)

- One (1) point for each county, parish, or district sign from A-Z. The word “county,” “parish,” or “district,” or the abbreviation equivalent, must be on the sign, as well as the name of the county, parish, or district. Only one point per letter. (26 points maximum)
- One (1) point for each U.S. state. The name of the state or abbreviation equivalent must appear on the sign. (50 points maximum)
- One (1) point for each country. The name of the country or abbreviation equivalent must appear on the sign.
- One (1) point for each Canadian province and territory. The name of the province or territory, or abbreviation equivalent, must appear on the sign. (13 points maximum)
- One (1) point for each U.S. National Forest sign. The name of the forest as well as the words “National Forest” must appear on the sign. (5 points maximum)
- One (1) point for each individual Harley-Davidson dealership. ( 25 points maximum) Dealership photos used for city, state, and province points may be used. However, a separate photo must be submitted for each point.
- One (1) point for each U.S. National Park Service (NPS) managed site and for each National Park or Provincial Park in Canada. The NPS logo with name and/or the name of the park, historic site, lakeshore, monument, etc., as well as the words “National” or “Provincial,” must appear on the sign. Visit [nps.gov](http://nps.gov) for U.S. parks and [pc.gc.ca](http://pc.gc.ca) for Canadian parks (see applicable provincial website for Provincial Park locations). (5 points maximum)
- Canadian Provincial/Regional and U.S. H.O.G. Rallies or H.O.G. Member Check In as listed at [hog.com/events](http://hog.com/events). The rally photo must clearly show you (the entrant) and an official rally banner or a national Harley-Davidson staff member. The H.O.G. rally event banner may not always be accessible with your motorcycle. In such cases, a photo of you (the entrant) at the location holding either a 2018 HOG magazine or the 2018 H.O.G. Touring Handbook will be accepted. This is the only situation that does not require your motorcycle in the picture. (No Maximum)
  - Three (3) points for each 2018 International Rally (outside the country you reside) that is listed as the National Rally for that country.
  - Three (3) points for each 2018 U.S. H.O.G. Rally or Canadian Provincial/Regional H.O.G. Rally.
  - Three (3) points for each 2018 U.S. or Canadian H.O.G. Member Check In.
- Three (3) points as listed below for each of the following Harley-Davidson Motor Company facilities. (18 points maximum)
  - Juneau Avenue Headquarters in Milwaukee, WI

- Pilgrim Road Operations in Menomonee Falls, WI
- York Vehicle Operations in York, PA
- Kansas City Operations in Kansas City, MO
- Tomahawk Operations in Tomahawk, WI
- Harley-Davidson Museum® in Milwaukee, WI. (Please do not park on sidewalks while taking your photo at the Museum.)

**PRIZES AND APPROXIMATE RETAIL VALUES (“ARV”):**

FIRST PLACE: \$1,500 Harley-Davidson® Gift Card; \$75 Norscot Gift Card for exclusive HOG Merchandise; 1st Place Plaque plus recognition at the Harley-Davidson Museum®, HOG Magazine, and HOG Insider. Total ARV of First Place Prize: \$1,575 USD.

SECOND PLACE: \$1,000 Harley-Davidson Gift Card; \$50 Norscot Gift Card for exclusive HOG Merchandise; 2nd Place Plaque plus recognition at the Harley-Davidson Museum, HOG Magazine, and HOG Insider. Total ARV of Second Place Prize: \$1,050 USD.

THIRD PLACE: \$500 Harley-Davidson Gift Card; \$25 Norscot Gift Card for exclusive HOG Merchandise; 3rd Place Plaque plus recognition at the Harley-Davidson Museum, HOG Magazine, and HOG Insider. Total ARV of Third Place Prize: \$525 USD.

For First Place, Second Place, and Third Place only, limit one (1) prize for household.

100 POINTS OR MORE: ABCs pin and patch, \$50 Norscot Gift Card for exclusive HOG Merchandise. Total ARV: \$60 USD.

51 TO 99 POINTS: ABCs pin and patch, \$25 Norscot Gift Card for exclusive HOG Merchandise. Total ARV: \$35 USD.

5 TO 50 POINTS: ABCs pin and patch. Total ARV: \$10 USD.

*Additional Prize Details.* Winning a prize is contingent upon fulfilling all requirements set forth herein. Taxes on prizes are the sole responsibility of the winner (if applicable). Gift cards subject to terms and conditions. Any and all guarantees and warranties for prizes are subject to the manufacturer's and/or service providers terms and conditions, and winner agrees to look solely to such manufacturers and/or service providers for any warranty or guarantee claim. Prizes and prize components are non-transferable and no substitution or cash equivalent is allowed except in Sponsor's sole discretion. Sponsor reserves the right to substitute prizes or prize components, for the same approximate retail value. **SELECTION OF WINNERS:** Photo submissions will be evaluated by Sponsor's employees or representatives selected by Sponsor to confirm that photos accurately depict the categories selected by entrant and comply with photo submission requirements. Points will then be calculated for each participating HOG member based on the scoring system outlined above. The HOG member with the highest total number of points from among all entrants (*i.e.*, both U.S. and Canada) will be declared the potential First Prize winner (pending verification of eligibility and winner confirmation); the HOG member with the second highest total number of points from among all entrants will be declared the potential Second Prize winner (pending verification of eligibility and winner confirmation); and the HOG member with the third highest total number of

points from among all entrants will be declared the Third Prize winner (pending verification of eligibility and winner confirmation). In the event of any ties, the tied entry with the most points in the city, village, town, township, or municipality category (from A-Z; 26 points maximum) will prevail. If a tie still exists, the tied entry with the most points in the county, parish, or district category (from A-Z; 26 points maximum) will prevail. If a tie still exists, the tied entry with the most points for individual Harley-Davidson dealerships (25 points maximum) will prevail. If a potential winner is found to be ineligible or does not comply with these Official Rules, or otherwise does not accept his/her prize as awarded, he/she will be disqualified and the entrant with the next highest score will be named a potential winner. Sponsor's decisions shall be final and binding in all matters pertaining to the judging, tallying of point totals, and selection of the winners.

In addition to the First Place, Second Place, and Third Place prizes, all HOG members who achieve point totals of 100 points or more, 99-51 points, or 50-5 points will win the prizes outlined above for their respective point tier.

Judging and tallying of points is expected to be completed on or about March 31, 2019. First, Second and Third Place potential winning entrants will be notified on or about April 30, 2019 by phone or email, in the Sponsor's sole discretion, using the contact information associated with the entrants' HOG account.

Odds of winning depend on number of entrants and each entrant's ability to collect points based on the stated criteria.

**WINNER CONFIRMATION:** To be confirmed as a First, Second, or Third Place winner, entrants must: (1) respond within five (5) days to the notification; (2) the selected entrant and guest may be required to execute and return within a specified time, an Affidavit of



Eligibility/Declaration of Compliance and Publicity Release (including SSN, if selected entrant resides in the U.S.), prize acceptance form, tax information (if applicable), assignment of rights, publicity release, and/or mutually acceptable liability releases as requested by Sponsor, except where prohibited by law; and (3) if selected entrant is a legal resident of Canada, complete a time-limited mathematical skill-testing question, to be conducted by telephone at a mutually convenient time. If a selected entrant cannot be confirmed as a winner as described above, he/she may be disqualified and the correlating prize may be awarded to an alternate entrant using the same confirmation process. Sponsor will attempt to notify each potential winner as set forth above, but Released Parties are not responsible for any undelivered messages that are not received because of a winner's privacy or spam filter settings which may divert any Contest email, including any winner notification email, to a spam or junk folder.

For prizes associated with the point tiers (*i.e.*, 100+, 99-51, 50-5), these prizes will be awarded via mail by April 30, 2019 using the members contact information associated with the members hog.com account.

**PUBLICITY RELEASE:** Except where prohibited, participation in the Contest constitutes entrant's consent that his or her name, likeness, voice and/or biographical data, including but not limited to photos submitted in connection with this Contest, may be used for advertising and promotional purposes without limitation and without additional notice, compensation, or consent.
